HOW TO GET GWC WARRANTY GAP

GWC Warranty GAP coverage must be purchased at the time you finance your vehicle. If you choose to be covered, the GAP waiver will amend the terms of your finance agreement.

Will your insurance pay 100% of your loan balance if you total your vehicle?

If your vehicle is in an accident and totaled or if it is stolen and not recovered, the settlement amount paid by your insurance company may be less than the amount you owe under your vehicle finance agreement. You may be responsible for the remaining balance and the cost of a new vehicle. This "gap" in coverage may be very costly to you. For example:

Amount left on your finance agreement

Your Insurance Settlement \$11,000 \$12,000 value, less your \$1,000 deductible The Gap \$3,000 Amount you still owe on lost vehicle
