

PRIVACY NOTICE

AN IMPORTANT NOTICE CONCERNING YOUR PRIVACY PLEASE READ THIS NOTICE CAREFULLY TO HELP US PROTECT YOUR PRIVACY

- 1.) Maintaining your trust and confidence is high priority. We want you to understand how we protect your privacy when we obtain information about you and how we may use that information, and how we safeguard that information.
- 2.) We obtain non-public information about you from: Information we receive from you on applications and other forms. Information about your transactions with us, our affiliates, or others such as your account balance, payment history, banking accounts, credit record: and information about your credit worthiness, credit history, and other information we receive from consumer credit reporting agencies.
- 3.) We may disclose all of the information that we obtain about you as described above, while you are a consumer, customer or former customer, to our affiliates and to non-affiliate third parties.
- 4.) We may disclose non-public personal information about you while you are a consumer, customer or former customer, to the following types of third parties.
 - a. Financial service providers, such as banks, finance companies, credit bureaus, and insurance companies.
 - b. Non-financial service providers, such as automobile manufacturers, direct marketers, warranty providers, and automobile security device companies.
- 5.) We may also disclose non-public personal information about you to non-affiliated third parties as permitted by law.
- 6.) We may disclose non-public information about you to our affiliates for the purpose of fulfilling your request or offering other products and services that we think may be of service to you.

OPT OUT OPTION

7.) If you prefer that we don't disclose non-public personal information about you to non affiliated third parties, you may opt out of those disclosures; that is, you may direct us not to make those disclosures (other than disclosures permitted by law). If you wish to OPT-OUT of disclosures to non-affiliated third parties, you may do so by placing a check mark in the box below.

Please be aware, that should you OPT-OUT, we will be prohibited from disclosing your credit record and other references to non-affiliated third parties except as permitted by law.
